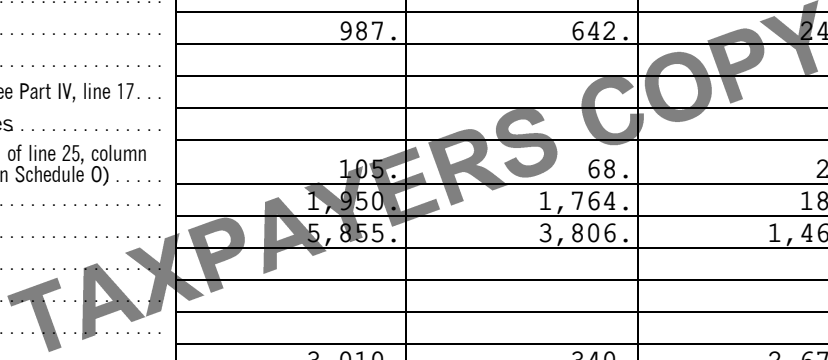

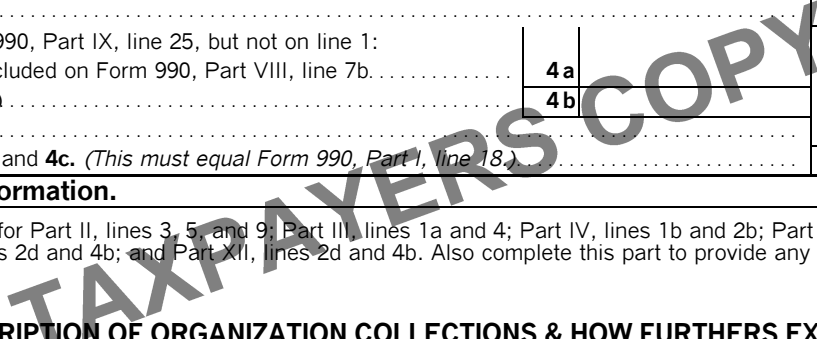

THE RECOMMENDED ACTION IS THEN PROVIDED AT THE WHOLE BOARD OF DIRECTORS REGULAR SCHEDULED BOARD MEETING. THE BOARD THEN TAKES ACTION/APPROVAL ON THE ITEM BY A VOTE. THESE RECOMMENDATIONS AND THE MEETING ACTIONS ARE RECORDED IN THE ORGANIZATIONS MEETING MINUTES.
